Feedback Obtained

As per the guidelines set forth by the UGC, our college has established a robust feedback-collection system overseen by the IQAC and academic council. Students are encouraged to provide honest feedback on various academic, administrative, and organizational aspects. Once the feedback data is gathered, it undergoes thorough analysis, and specific suggestions are communicated to concerned teachers during meetings facilitated by the Principal and IQAC coordinator. These suggestions focus on individual teaching approaches, if necessary, and are evaluated for feasibility and practicality. Every potential area for improvement is carefully considered, and appropriate actions are taken upon determining the need and feasibility of specific amendments or modifications. For instance, in response to feedback indicating inadequacies in meeting the demands of the updated syllabi under the CBCS system, the college decided to invest in paid online resources to supplement the existing library collection. Similarly, suggestions from the Central Library regarding the procurement of more advanced software to streamline metadata organization and management were approved, recognizing the benefits it would bring to both users and officials. The feedback system extends beyond academics to encompass a wide range of concerns, including but not limited to classroom teaching methods, availability of amenities, behavioral issues, environmental concerns, campus cleanliness, educational tours, ICT support, sports-related needs, and accessibility requirements.
