<p>In line with IQAC recommendations, our college has implemented a robust Learning Management System (LMS). This platform centralizes the distribution of learning materials for students, including course syllabi created by instructors and essential university question papers. Following IQAC recommendations, our college has implemented a user-friendly e-Diary system. This electronic tool streamlines record-keeping for faculty by allowing them to track daily academic and administrative tasks, including the number of classes held, leaves taken, administrative duties performed, and seminar/conference attendance. In collaboration with other departments, IQAC hosted a series of informative seminars (5). Students actively engaged in extracurricular activities, including 22 outreach programs and 29 sports and cultural events. Following IQAC recommendations, our college has implemented a user-friendly e-Diary system. This electronic tool streamlines record-keeping for faculty by allowing them to track daily academic and administrative tasks, including the number of classes held, leaves taken, administrative duties performed, and seminar/conference attendance. Having submitted the IIQA for this cycle, the IQAC is now tackling the remaining aspects of the second NAAC assessment. The COVID-19 pandemic necessitated a shift to virtual platforms for most of our college's sports, cultural, and outreach activities. We're excited to gradually resume these activities in-person once the situation permits.</p>

**15. Multidisciplinary / interdisciplinary**

Sonarpur Mahavidyalaya, a general degree college, fulfills a vital mission by providing higher education to students in its locality and as well as in the remote Sundarbans region. The college offers a multidisciplinary curriculum with three core streams: Science, Arts, and Commerce. This translates to 28 programs under the University of Calcutta's CBCS system, catering to a student body of approximately 3,500. Recognizing the value of interdisciplinary learning, the college actively encourages students to explore beyond their primary stream. Science students have the opportunity to incorporate courses from Arts or Commerce, and vice versa. This existing practice positions Sonarpur Mahavidyalaya perfectly to embrace the interdisciplinary and multidisciplinary focus outlined in the National Education Policy (NEP) 2020.

**16. Academic bank of credits (ABC):**

Sonarpur Mahavidyalaya is a proud affiliate college of the University of Calcutta. We adhere to the university's prescribed curriculum and programs. Semester examinations are centrally conducted by the university, and they hold the authority to award marksheets based on evaluations by faculty, potentially from various affiliated colleges. Since the university manages the credit and grading system, the college currently lacks the autonomy to implement a full-fledged Academic Bank of Credits (ABC) program. However, we are enthusiastic about the potential benefits of ABC and eagerly await any future government regulations that might allow us to actively participate in such a system.

**17. Skill development:**

Sonarpur Mahavidyalaya recognizes the importance of graduating students who are not only well-educated but also equipped with practical skills. The CBCS curriculum itself fosters skill development through its outlined syllabi. Additionally, the college offers free certificate and add-on courses targeted specifically to

enhance these skills. Each department takes the initiative to design and provide add-on courses relevant to their respective disciplines.

#### **18.Appropriate integration of Indian Knowledge system (teaching in Indian Language, culture, using online course)**

One of the college's notable strengths lies in its provision of Major languages such as English and Bengali. These languages attract a significant number of students who enroll to study them. The college adopts a bilingual teaching approach, with instructors delivering lectures in both English and Bengali. Specifically, English-speaking students, on the other hand, receive lectures exclusively in English. Furthermore, students who are proficient in both Bengali and English benefit from lectures delivered in a bilingual format.

#### **19.Focus on Outcome based education (OBE):Focus on Outcome based education (OBE):**

The college is dedicated to preparing its students for success in the competitive job market upon completion of their programs. In line with this goal, the college proactively offers Add-on courses aimed at enhancing students' skills. These courses, developed by the University as part of the Choice Based Credit System (CBCS) curriculum, align closely with the specified course outcomes.

Given that the college operates as an affiliated institution under the University of Calcutta and is governed by the Government of West Bengal, it lacks autonomy in designing or altering its core curriculum, with the exception of certificate and add-on courses. However, the college is committed to ensuring that students achieve the desired course outcomes.

To this end, departments within the college employ a mechanism, established by the Internal Quality Assurance Cell (IQAC), to assess and analyze the attainment of course outcomes. This mechanism incorporates both direct and indirect methods of evaluation, enabling a comprehensive understanding of students' academic progress and skill development. Through this Outcome-Based Education (OBE) approach, the college strives to equip students with the necessary competencies to excel in their chosen fields upon graduation.

#### **20.Distance education/online education:**

During the recent pandemic, the college seamlessly transitioned to online teaching methods, ensuring continuity in education for its students. Additionally, the college has introduced Add-on courses for students in every department, delivered online during zero

hours, which fall outside the regular stipulated college hours. These courses, tailored to each department's subject area, are offered free of charge and focus on skill enhancement. Moving forward, the college aims to enhance these courses further by incorporating an industry-centric approach, equipping students with practical insights to enhance their competitiveness in the job market.

1.1.1 - The Institution ensures effective curriculum delivery through a well planned and documented process

The college adheres to the curriculum set by the University of Calcutta, ensuring effective delivery through a transparent process. At the start of each session, the Prospectus and Academic Calendar are prepared under the guidance of the Teachers' Council and Academic Committee, and these documents are published on the college website. Before each session or semester begins, departmental meetings are convened to allocate classes among teachers based on the academic calendar and syllabus. Department heads submit the anticipated number of required classes per week to the Secretary of the Teachers' Council. The Teachers' Council then develops the

Master Routine (Time Table), which serves as the foundation for departmental schedules. The Principal approves all departmental timetables. Additionally, teachers in each department create detailed month-wise teaching plans aligned with the University of Calcutta's syllabus, which are uploaded to the college's Learning Management System (e-Shikshak). This facilitates monitoring of syllabus progression by the Principal. Furthermore, regular assessments of curriculum delivery are conducted by the Academic Committee and IQAC.

Sonarpur Mahavidyalaya diligently follows the academic calendar, meticulously planning various academic activities at the onset of each academic session. Aligned with the schedule provided by the affiliating university, the college inserts tentative dates for admission, class commencements, internal examinations, and final examinations into its academic calendar. This calendar serves as a guiding framework for notifying faculty and students about the timing of these activities. Faculty members rely on this calendar to structure their teaching plans effectively. Teaching plans from all departments are meticulously uploaded onto the college's Learning Management System (LMS). Department heads maintain close oversight to ensure the timely completion of syllabi as per the teaching plans.

Continuous Internal Evaluation (CIE) is an integral component of the academic process at Sonarpur Mahavidyalaya. Faculty members assign tasks and assessments according to department-specific teaching plans, ensuring students' continuous engagement with the curriculum. Internal examinations are conducted in accordance with the academic calendar. Based on student responses and performance in assignments and class tests, special classes are organized to support slower learners.

The Principal takes proactive measures to ensure the effective implementation of the academic calendar. Formal meetings of the Academic Committee provide a platform for review and planning, while

informal discussions with faculty members further facilitate alignment with the calendar's objectives. This systematic approach ensures that academic activities proceed smoothly, fostering a conducive learning environment at Sonarpur Mahavidyalaya.

At the onset of each academic session, a comprehensive academic calendar is diligently crafted, aligning with the affiliating university's schedule. This calendar encompasses key dates for admission, commencement of classes, internal examinations, and final examinations.

Departments follow tailored teaching plans, assigning assignments to students in accordance with their specific curriculum. Internal examinations are conducted as per the academic calendar and syllabus structure.

Under the Choice Based Credit System (CBCS), internal assessment constitutes 35% of the total marks, with 10% allotted for attendance, 10% for internal assessment, and 15% for tutorial projects. In practical-based subjects, internal and external evaluation each contribute 50% of the marks. For practical-based subjects, in addition to attendance (10%) and internal assessment (10%), 30% of marks are allocated for practical examinations.

This internal assessment mechanism ensures transparency and robustness, incorporating a balanced mix of attendance, internal assessment, and practical evaluations to comprehensively evaluate students' academic progress and performance at Sonarpur Mahavidyalaya.

By combining 80% of the direct method score with 20% of the indirect method score, the institution calculates attainment level scores for each course. These scores are categorized as low, moderate, or high based on specific percentage ranges. This meticulous evaluation framework ensures a comprehensive understanding of student achievement and guides continuous improvement efforts to enhance educational outcomes at Sonarpur Mahavidyalaya.

The renovation of staff toilets and the procurement of books were successfully completed within the allocated timeframe. The actual expenditure for maintenance of academic facilities (excluding salaries for human resources) amounted to INR 82,681, while maintenance expenses totaled INR 19,04,490. This efficient execution demonstrates prudent resource utilization in line with the strategic plan.
